



## V D11NR 2012 Statistics\*

Additional stats from AUXINFO\* indicates that **611** or **32%** of our VSC's are First Time VSC's. In addition **699** or **37%** are High Risk VSC's.

-ORION RE-LAUNCHES INCENTIVE PROGRAM FOR VESSEL EXAMINERS For the last five years Orion has recognized the important role Coast Guard Auxiliary volunteers play in promoting boating safety by sponsoring the Orion Safety Awareness Program. The program continues to grow and now includes more than 1,000 participants. The Orion Safety Awareness Program now re-launches with new and enhanced features. The most significant changes to the program are the new Submission Form (which must be submitted monthly), and points which can be redeemed for Orion Safety Cards redeemable for a variety of products at West Marine stores. Points will not be accepted if they are not submitted in a timely manner. For prior enrolled members, points will carry over to the new program. -2012 Vessel Examiner Recognition Changes. The special D11NR Vessel Examiner recognition program for 2012 will be modified as follows-The certificate of appreciation and special token of thanks will be eliminated. Recognition for 20+ VSC activity will be limited to the examiner name appearing in the DSO-VE monthly activity report to EXCOM and will be placed on the D11NR Vessel Examiner website under "Recognition" page. However, the special recognition for 60+ VSC's will not change. To qualify for this recognition, your VSC activity performed **MUST** be entered and shown in AUXINFO **PRIOR** Monday November 5, 2012!
