



## **V**D11NR 2011 Statistics\*




### **VPAC AREA 2011 Statistics\***



The goal for D11NR was 11,000 VSC's. We are 107% of our goal for the year and 110% of 2010 production at this time! The data source is AUXINFO\*. The goal for 2012 is 12,000 VSC's. Additional stats from AUXINFO\* indicates that 6,824 or 58% of our VSC's are First Time VSC's. In addition 7,251 or 61% are High Risk VSC's. \*Statistics as shown in AUXINFO thru December 31, 2011

#### -2012 VSC Decals Order Information

The 2012 VSC Decals are now available for ordering from ANSC. As in the past, ONLY the CURRENT FC or FSO-MA or the Division counterparts can order decals and supplies. Decals will NOT be automatically sent and you MUST submit the completed 2012 order form! Please go to the D11NR Vessel Examiner website:

http://rbsafety.d11nuscgaux.info/ve/ve.html and under "HOTLINE MESSAGES" to find the 2-page form, print and fax it to ANSC. As in the past, please do not request a decal quantity, ANSC will handle that number based on VSC activity from July 2010 to June 2011 plus 10%. Please do not wait to order your initial allocation.

The decals should be given to the FSO-VE and distributed to flotilla examiners based on 2011 activity shown in AUXINFO. Also be sure to plan ahead for NSBW, VSC Inland Lake Blitz Days, and VSC Mega-week promotion. Please remember that the Division is the flotilla immediate emergency back up source. Please do NOT request supplies from me. Additional supplies from ANSC will be available as the year progresses.

Lets submit our orders ASAP to provide the boaters the service in 2012 that they've come to expect. This will in turn make 2012 another banner year for D11NR VSC production! A similar notice has been will be sent to all Vessel Examiners by National on 12/18/2011.

- -2012 Vessel Examiner Recognition Changes. The special D11NR Vessel Examiner recognition program for 2012 will be modified as follows-The certificate of appreciation and special token of thanks will be eliminated. Recognition for 20+ VSC activity will be limited to the examiner name appearing in the DSO-VE monthly activity report to EXCOM and will be placed on the D11NR Vessel Examiner website under "Recognition" page. However, the special recognition for 60+ VSC's will not change. To qualify for this recognition, your VSC activity performed MUST be entered and shown in AUXINFO PRIOR Monday November 5, 2012!
